## TRANSPORTED COOLED SEMEN BREEDING CONTRACT

This certifies \_\_\_\_\_ herein referred to as the Mare Owner, has engaged one breeding to

**You Bet Im Good** for the **2009** breeding season at \$ \_\_\_\_\_ for the following mare:

Sands Quarter Horses, agent for the above named stallion, will herein be referred to as Breeder.

This agreement subject to the following terms and conditions:

1. A non-refundable Booking Fee \$ **300.00** is payable when this contract is signed and returned. This fee is applied to the total breeding fee the balance \$ \_\_\_\_\_ of which is payable before semen is shipped.
2. The first Collection Fee will be courtesy of Sands Quarter Horses. Shipping Charges at the rate of \$ **200.00** via Fed Ex will be mare owners responsibility which is payable prior to transporting semen. All subsequent collection fees will be \$**150** prior to semen shipment. Shipping and semen box container will be included in this rate. (Fed Ex priority overnight) Counter to counter shipments going to the airport will be \$ **400.00**.
3. A photocopy of the registration papers shall be sent to Sands Quarter Horses with this contract.
4. When ordering semen: All requests should be made prior to **11 a.m.** Missouri time. Semen will be collected on **Mondays, Wed and Fridays**. We highly recommend sending your mare to a vet clinic or breeding farm for her heat cycle. They will coordinate optimum shipping times with us. Mares sent to the ranch will receive preference for semen availability.
5. The breeding season in force for this contract shall begin **February 1st and close June 30th** of the year on this contract.
6. Live Foal Guarantee: Live Foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a return season will be guaranteed the following year providing notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Booster rhinopneumonitis vaccinations must be administered as indicated by the individual drug manufacturer, as the mare progresses through her pregnancy. **Failure to do this will void the Live Foal Guarantee.**
7. It is further agreed that should the above named stallion die, or become unfit for service, or, if the above named mare dies, during the breeding season then the Mare Owner may substitute another mare or breed the above named mare to another stallion on the farm that is agreed to by both the Mare Owner and Breeder.
8. All rebreeds will be charged a \$ **200.00** fee the following year.
9. A breeders certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of the birth of the foal.
10. The signing of this contract entitles Breeder to charge 12% annual interest on all past due invoices. Past due billing is defined as those amounts not paid within 30 days of invoicing.
11. When the above named Mare Owner signs and returns one copy of this contract to the Breeder it will then be a binding contract on both parties, subject to the above terms and conditions. This contract is not valid unless completed in full.
